



# Getting Started Guide

# Welcome to Fairfield County's Giving Day

This guide will lead you through the steps for registering and getting started. We've also outlined some key dates to make note of leading up to the event!

## Are You Eligible?

**Giving Day is open to nonprofit organizations that meet the following criteria:**

- It is a registered tax-exempt organization under section 501(c)3 of the IRS code
- Funds raised on Giving Day must directly benefit Fairfield County residents or programs located in Fairfield County

**Special requirement for programs operated within and under a higher-education tax exempt status:**

- Specific program, department or scholarship must be listed as the focus of fundraising during the Giving Day campaign

**Special requirement for organizations and programs operated with religious intent, mission and purpose:**

- Allocate 100% of funds generated through this campaign for non-religious programs, services and activities (i.e. food pantry, educational programs)
- Allow individuals to benefit from the specified program, service or activity without discrimination on the basis of religion, race, color, sex, sexual orientation, age, national origin, ancestry, citizenship, veteran, or disability status
- Specify the program, service or activity that the funding will support



## Are You Eligible? (continued)

### Your organization is not eligible for participation if:

- It is a political, labor or fraternal organization
- It is a church, synagogue or similar religious organization (review special requirement for organizations and programs operated with religious intent, mission and purpose above)
- It is a K-12 school (public or private) - PTAs/PTOs are eligible to register if they have a tax-exempt status
- It is a sports program (for example, Little League or Pop Warner)
- It's only purpose and function is grantmaking
- It is an organization that denies service to a potential client or beneficiary on the basis of race, religion, color, sex, sexual orientation, age, national origin, ancestry, citizenship, veteran, or disability status
